

One Call 2024 Code of Conduct

Saint John’s University

All applicants to One Call are required to fill out the following Code of Conduct Form prior to acceptance so that there is a clear understanding of what is required of you, should you be accepted. The following Code of Conduct is presented to ensure that all One Call participants experience an atmosphere of care, safety, and respect. Parents and participants are responsible for reviewing and following these expectations.

PLEASE READ THE FOLLOWING GUIDELINES CAREFULLY BEFORE SIGNING IN THE AREA BELOW.

- Participants are expected to take part in and be on time for all One Call program activities: daily morning and evening prayer, concerts, workshops, rehearsals and other scheduled events. Optional events will be clearly listed in the schedule.
- Participants are expected to be present at ALL meals (including breakfast each day – regardless of whether breakfast is a typical meal for them or not). This expectation is in place to help foster our community.
- For participants' safety and insurance purposes all youth participants are expected to remain on SJU campus at all times during the program (June 25-June 29, 2024).
- All participants need to return to the dormitory by the designated check-in time and must be in their assigned rooms by the designated lights-out time. Rest is essential for participants in order to be able to stay healthy and to fully participate in this program.
- Participants are expected to abide by all rules and limitations on the use of cell phones and electronic devices.
- Participants are responsible for their room keys and any damage to campus property. Lost keys are subject to a replacement fee that participants will be responsible to pay. Property damage will be assessed.
- ALL injuries or medical concerns about yourself or any other participant must be reported to an adult One Call staff member at once.
- Participants must follow COVID protocols as designated by Saint John’s University and One Call based on current health conditions at the time of the institute.
- Inappropriate language is not acceptable. This includes but is not limited to swearing, derogatory or threatening words.
- Alcoholic beverages, smoking and/or illegal drugs are not allowed. Any participants who are 18 years or older must abide by the same rules and expectations and will be under the same potential consequences.
- Fireworks, firearms, knives or any other weapons are strictly prohibited.

If the guidelines above are not followed, or additional behavioral issues arise, One Call staff will determine what actions, if any, need to be taken. Any action will be determined on a case-by-case basis, but ultimately could result in dismissal from the program without a refund, by discretion of the program directors and/or university administrators.
